SUBJECT: Blanket Exception to Army Policy Volume 2008, Defense Civilian Intelligence Personnel System Awards and Recognition for Fiscal Year 2022

1. References:

- b. HQDA G-2 (DAMI-CP) memorandum (Fiscal Year 2022 Defense Civilian Intelligence Personnel System Guidance on Pay Pools, Awards, and Reporting of Results for Non-Defense Intelligence Senior Executive Service and Non-Defense Intelligence Senior Level Positions),15 Dec 21
- 2. I approve a blanket exception to the above references for the remainder of Fiscal Year 2022 (FY22) waiving the requirement that non-rating based award amounts for DCIPS employees not exceed \$2,000 regardless of the value of benefit and extent of application without an exception to policy. Submit proposed awards in the amounts greater than \$10,000 through this office for my review and concurrence prior to further coordination and approval in accordance with reference 1.a.
- 3. This blanket exception is granted due to the additional 1% increase in FY22 awards budget, as given in FY21, for non-rating based lump-sum monetary awards (e.g. one-time special act or service awards and on-the-spot awards) allocated in reference 1.b. Lifting the \$2,000 awards cap improves recognition commensurate with accomplishments and enables spending of entirety of awards budget allocated for FY22.
- 4. This exception for FY22 is effective upon publication of this memorandum. My approval of such exception does not ratify any personnel actions made outside of policy prior to the effective date of this memorandum.
